THE WORK TO BE CARRIED OUT IS THE REMOVAL OF TWO BRANCHES FROM A HORSE CHESTNUT TREE AND A SINGLE BRANCH FROM A LIME TREE. THE HORSE CHESTNUT TREE IS NUMBERED (1) ON THE PLAN AND THE LIME TREE IS NUMBERED (2) ON THE SKETCH PLAN. THE REASONS FOR THE WORK ARE TO REDUCE THE AMOUNT OF LEAVES, CONKERS, BLOSSOM AND ASSOCIATED DEBRIS FALLING IN OUR GARDEN AND BEING DEPOSITED IN OUR GUTTERS AND DRAINS. ALSO TO INCREASE NATURAL LIGHT LEVELS IN OUR PROPERTY.
