CROSSRAIL ACT 2008 – SCHEDULE 7 PARAGRAPH 11 (2) – SHENFIELD STATION WORKSITE RESTORATION SCHEME BRENTWOOD BOROUGH COUNCIL (SUBMISSION REFERENCE: BRE/4/11/NR)

This is a request for the agreement of details to restore a worksite used for Crossrail works at Shenfield Railway Station back to its previous state. Under Schedule 7, paragraph 19 (2) to the Crossrail Act 2008 we submit the following details for agreement by Brentwood Borough Council:

- Site Location Plan (drawing reference 7007960-SHENFIELD-01) For Information Only
- Proposed Restoration Area (drawing reference 7007960-SHENFIELD-08)

Following the discontinuation of the use of the worksite, the restoration proposal outlined in the above drawing will remove the following elements:

- temporary construction hoarding and heras fencing that runs along the new retaining wall and the side passageway to the rear of the shops;
- existing bin storage, including the palisade fencing that ties the bin store and temporary hoarding

The proposal for the site is to leave a cleared site, retaining only the permanent structures previously existing or consented under Schedule 7 consents (17/00787/CROSS, 16/00993/CROSS, 15/00699/CROSS and 14/01016/CROSS). To restore the worksite back to its previous state, the restoration proposal also includes reinstating the following elements:

- Worksite curtilage to be re-surfaced with bituminous surfacing;
- Disabled parking bay to be re-surfaced with Type 1 material and bituminous surfacing and lines painted.



The following permanent works will be completed under a separate Schedule 7 Plans and Specifications application:

- Steel palisade fencing;
- Steel palisade gate to new bin storage area, and
- Reinstated taxi rank cabin

The Crossrail Planning Fee Regulations 2008 do not require a fee to paid in respect of schemes submitted for agreement under Schedule 7 Paragraph 19.

We trust these details give you sufficient information to agree the scheme without delay.
