See photo. Tree species is unknown. I'm no expert. It is deciduous. There are no leaves to help with identification. Tree is in the red ring on the plan. Our tree surgeon said it had Honey Fungus two years ago. We had it cut back to try to save it. Obviously it failed. We now need to cut it down as it would hit the house if it fell. As can be seen in the photo, there are many other trees around it. They are already starting to self seed and new saplings are growing.
