Conifers T1-T7 - fell because outgrown useful life as a hedge and are now the subjects of a complaint from neighbours. T1 - T6 will be replaced by a native species hedge (e.g. hawthorne) as recommended by the planning officer who attended in response to my previous request to fell two holy trees. (see 21/00291/TCON)
Tree T7 is a different species of conifer which has grown in such a way that pruning is difficult without damaging the shape of the tree. It will not be replaced because it is near the house and also blocks late evening sunshine.
