e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Ash - reduce by 25%, removing branches of between 1.5-2.5 metres in length throughout the whole crown to leave with a balanced crown and tidy shape. Give building clearance of up to 1.5 metres. Remove deadwood.

Target prune to an appropriate union, stems which have snapped, torn or been left with no growth points.

To improve light levels to all stories of the building, improve light to the garden, give building clearance to prevent damage to tree and building.
