T3 Thuya - This tree although very sturdy the main trunk is beginning to look a bit sick. I had Long Acre Tree Surgery inspected it and they said that it had outgrown its place and it had big spurs growing out from the trunk which were taking up the nutrition from around it. I would like to trim a few of the lower branches that overhang my patio as pigeons roost there at night and the patio around the back door is covered in droppings. I have small grandchildren come to visit and it is not pleasant when they are outside. Also there is excessive shading in that area.
