Further to my previous email I have now spoken with my Team Leader re the Ground Source Heat Pump at Woolbeding, and we suggest that there are two options:

Option 1 – Submit a Variation of Condition application with regard to the plans. With regard to your planning consultants concerns for each condition that has been discharged we would re-word to show that they had been discharged under the current application. It is unlikely that we would consult all of the consultees, only consulting where we saw fit for the nature of the works.

Option 2 – Submit an application purely for the GSHP with the red line surrounding the area and leading to the Plant Room.

With either option we would consult only the consultees that we thought were necessary for the nature of the works, and therefore you would not be required to submit an Ecology report. The main area of concern would be the root protection area of the nearby tree, and therefore the Tree Officer is likely to be notified.

I hope this information has been of assistance.
