As you are aware, Listed Building Consent was granted for the erection of a single storey rear extension to the kitchen and replacement of a first floor window.

Condition 1 – We confirm that our client intends to commence works within 3 years of the approval date.

Condition 2 – We confirm that the works will be carried out in accordance with the drawings listed in the recent approval ref: 20/02969/HOU.

Condition 3 – We confirm that the materials used in the construction of the external surfaces of the development hereby permitted shall be as described in the application form and as annotated on the approved plans.

Condition 4 – The architect will submit large scale details of windows, doors and roof-lights, in due course.
