## Heritage Statement

White House Farm, Mundesley Road, Knapton, NR28 0RX

This statement forms part of a planning & listed building application for the replacement of 7 aluminium framed windows with 7 sash windows.

### 1. Introduction

Heritage Statement Para 189 of the National Planning Policy Framework states: "In determining applications, local planning authorities should require an applicant to describe the significance of any heritage assets affected, including any contribution made by their setting. The level of detail should be proportionate to the assets' importance and no more than is sufficient to understand the potential impact of the proposal on their significance. As a minimum the relevant historic environment record should have been consulted and the heritage assets assessed using appropriate expertise where necessary.

### 2. Proposal

Planning permission is sought for the replacement of inappropriate, poorly fitting, thermally inefficient, visually unappealing aluminium framed windows with sash windows, which are more in keeping with the age and historical aesthetics of the farm house.

### 3. Historic England Listing Entry

As can be observed from the entry on Historic England, this has been updated in 1987 to show the current aluminium framed windows, please see below, together with additional photographs.

KNAPTON MUNDESLEY ROAD TG 33 SW (north side) 4/75 The White House (formerly listed under Paston Civil Parish as 16.4.55 White House Farm) - II

Farmhouse. Late C18. Flint with brick dressings and roof of black glazed pantiles. 2 storeys in 4 bays. Door left of centre in plain but emphatic doorcase. Windows are late C20 casements under gauged segmental arches. Gabled roof with internal gable and stacks. Further stack on ridge right of centre. Gable walls colourwashed.





## 5. Justification

The current aluminium framed windows relate very poorly to the period of the listed building, they make no contribution to its special architectural or historic interest and are arguably of negative heritage significance (ie it caused harm to the character of the listed building creating cracks in almost all window installations, partially impacting on the fabric of the building)

The replacement windows are a more appropriate design for the period of the property, visually much more appealing and will be designed to be of 4 pane rather than 5, designed specifically for each window opening, ensuring a much better fit.

## 6. Access

Access arrangements are not affected by the proposed alteration.

## 7. Conclusion

For the reasons set out in this Heritage Statement the proposed alteration is compatible with the preservation of the listed building. As such the proposals comply with policies aimed at conserving and enhancing the historic environment.
