This woodland hosts an organisation called Raffles Forest School where young people of all ages go and spend time learning about trees and habitats, making things out of wood, crafting things and exploring the natural world we live in. There is huge concerns about the safety of these children as they learn and play, as in windy conditions branches are falling off these Ash trees.

There is also an extensive program of replanting going on by the children throughout this woodland, many many trees have already been planted and cared for, there are plans to plant many more. This really is a very good thing going on in this wood, and it is imperative that we make it safe for them to carry on as soon as possible.
