An application for a Hazardous Substances Consent on behalf of Ungerer Ltd. Our request for the consent is to enable us to store up to 200 tonnes of essential oils and aroma chemicals in containers (predominantly palletised 205 litre steel 205 drums with a smaller number of IBC's) on the premises of our warehouse facility which is located Unit 1, Stadium Way Bromborough.

A number of the substances, namely the essential oils, are classified as E1 Hazardous to the Aquatic Environment Category 1, which would take us beyond the threshold required to make this a lower tier COMAH establishment. Thus, the Control of Major Accidents and Hazards Regulations (COMAH) 2015 will become applicable as does the requirement for a Hazardous Substances Consent to be issued by the local Hazardous Substances Authority (HSA), in this instance Wirral Borough Council.

The facility is to be used for storage only and there is to be no manufacturing, treatment or other industrial processes carried out on the premises.
