e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Fell Multi stemmed Sycamore in front garden. Tree has out grown its location. It is a multi stemmed tree growing from one root bowl with included junctions. There are better younger trees in this small front garden that are being subdued by this large tree. Whilst reduction could be considered, this would only be a financial burden to the owner and only a short term fix. Any failure would result in damage and risk to life and property. The smaller trees will all benefit by the removal of this tree. Any failure would damage the smaller trees and result in a greater loss to the local tree scape. Early removal should sometimes be considered in special cases where it would benefit the long term tree scape.
