The condition stated "Prior to the erection/installation of any floodlighting or other means of external lighting at the site, details to include position, height, aiming points, lighting levels and a polar luminance diagram shall be submitted to and approved, in writing, by the Local Planning Authority."</p> <p>We subsequently corresponded with the Planning Officer at Babergh regarding the condition, who responded "There is a standard condition that was attached, for which the full extent of details in this is excessive e.g. the polar luminance diagram, so if you can just submit details of the positioning of the lighting and lighting specification and details this should be sufficient."</p> <p>As such, we have attached details of the lighting and lighting specification for your review and consideration.</p>


