Tree works to one mature Ash Tree (*Fraxinus excelsior*) which is developing signs of Ash dieback (*Hymenoscyphus fraxineus*) but is not in steep decline.

The following Works have been recommended by Mr Barney Jones of Cornish Trees and Gardens Liskeard: 20% crown reduction and a partial crown lift of all limbs reaching down towards the house and removal of any limbs which are showing disease or decay. All works to be carried out to BS3998.

There is a restrictive covenant on the property requiring nothing to be grown to be a nuisance, annoyance or damage or disturbance to the neighbours. The neighbours are concerned regarding the branches of the Ash tree overhanging their garden and causing loss of light.
