e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

5 Lime (Tilia) trees border our garden, between our house (Fosse Wharf) and our neighbours (Fosse Wharf Farm) to provide screening and privacy for our house from Fosse Wharf Farm's upstairs windows. They are on the opposite side of our property to the canal, as shown in the satellite image provided (trees identified as the five green dots on the image). They are getting overgrown and need to be maintained. This was previously done by the prior owners regularly before the area became part of the canal conservation area. Now as our property is part of the conservation area we are looking to obtain permission to perform maintenance on the 5 trees. We are not felling them, we are reducing their size and pruning them back into shape. We have obtained satisfactory quotes by qualified tree surgeons to "Perform an overall crown reduction & shaping of five Lime trees by up to 50% whilst still retaining screening." The trees are hardly visible from the canal.
