Vehicular access for a single car and excavation. Turning front stepped garden into a single parking space.

After excavation a new retaining wall will be built out of brick and or concrete reinforced block and rendered. Existing walls on the left and right of the house will remain (neighbours wall on the left) and will be rendered.

Soakaway will be installed in a 1000mm by 400mm hole, 5 metres from house wall and the hole lined with porous membrane. It will also be filled with 400mm stone up to 600mm.

An existing pathway at the entrance to the house will remain and have a rail gate installed to match the existing rail on the neighbours property in number 44 (up to 1.25m in height)

The existing stair case to the entrance of the property will remain and a hand rail maybe installed on the left side of the stairs, following the rail at the top.
