General trimming and tidying of neighbour's tree branches ( copper beech, silver birch, conifers, leylandi , chamaecyparis lawsoniana, ash, eucalyptus , prunus ) and bushes (forsythia , symphoricarpos ) overhanging our boundary/ touching our property back to boundary line. Plus pruning of conifer and hawthorn hedges within our property boundary. This work has been regularly applied for on other applications previously.
