Woodland Management Plan - Submission for Consent

Address: 3A, The Grange, Kirkby Road, Ravenshead, Nottinghamshire NG15 9HD

Overview: The current site has not benefitted from any active woodland management for at least 12 years and hosts a significant number of trees which are either dangerous or in an advanced state of deterioration. The site also exhibits an unusually high density of non-indigenous Cyprus trees that do not enhance the visual amenity of the plot or reflect the historical natural stock of trees which would typically be dominated by Silver Birch, Scots Pine, Sweet Chestnut, Oak and Small-Leaved Lime.

This application is intended to facilitate a plan that will be implemented over approximately five years in which the dangerous and deteriorating trees can be removed along with the stock of non-indigenous Cyprus trees and a programme of planting which reflects the natural habitat of Newstead Abbey Park which also improves the visual amenity of the site.

This submission is made following consultation with and a site-visit by David Simpkin, Tree Officer for Gedling Borough Council, on Thursday 27th May 2021 at 0900 in which detailed guidance and advice was given. This submission includes a site map and photographs.

The aim of this application is to protect the property from damage from dangerous trees, enhance the overall visual amenity of the site, reforest with indigenous species and encourage wildlife.

Application summary:

Removal of all non-indigenous Cyprus on the plot.

Removal of non-indigenous Cyprus hedging on the plot.

Pruning of non-indigenous Cyprus hedging to 3m.

Removal of Eucalyptus in a state of structural collapse caused by cavity decay.

Removal of multi-stem Sycamore with weakness at base.

Removal of Silver Birch with an unstable canopy due to storm damage.

Removal of Cedar in a state of decay.

Removal of Holly in a state of decay

Crown lift to 5 metres of multiple Silver Birch.

Reforestation by planting of species reflected in the natural landscape of Newstead Abbey Park such as Silver Birch, Scots Pine, Sweet Chestnut, Oak and Small-Leaved Lime around the perimeter of the plot.
