e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Trees within group of beech along boundary line -

T.1 - Beech - along driveway closest to garage - reduce larger lower limb overhanging drive back to secondary branch union.

Reduce smaller limb above back to secondary branch union. (See photo)

Reduce overall crown on driveway side by up to 1.5m to reduce crown overhang

T.2 - Beech to the left of T.1 - smaller lower limb on driveway side - reduce back to first branch union. (See photo)
