Large roots visible seen growing in direction of the drain which if left will cause damage. This drain also serves 2 adjoining properties along with our property. . Excessive shading in garden due to size and effecting growth of yew hedge.

T2 White Willow- Fell due to excessive shading, tree rot and roots causing considerable damage to lawn and new growing yew hedge .

We have appointed a tree surgeon [REDACTED] to come and assess the trees and give their advice. He advised felling both mature trees comming the above reasons. If you need to get in touch with him his number and email are provided.
