Spruce tree located top left corner of garden crown lift to 5m and crown reduce over seat by 1m

Conifer hedge - hedge cut to previous level to leave the top at 2m above ground level

Lilac hedge - reduce in height to leave at 2.1m above ground level.

Mixed hedge RHS - reduce in height to leave at 2.1m above ground level and pollard 2 sycamore in hedge (grey dots on map)

Apple Tree - re shape to form a more compact crown
