Our region is "on the cusp of something quite dangerous" as cases of the Indian variant continue to rise, an expert warned today

Dr Lisa McNally said the West Midlands was experiencing the "calm before the storm" after the number of Covid cases went up by more than 40 per cent in a

She said the fact that large numbers of people had still not been vaccinated meant there was a risk of Covid hospital admission rates starting to rise again.

It came as MPs urged ministers to "follow the science" amid calls to delay the ending of restrictions on June 21.

The Indian variant is now dominant in the West Midlands. Cases rose by 41 per cent in the week to June 1. Birmingham's infection rate is up to 42 cases per 100,000 people and Walsall's is at 35.

Dr McNally, Sandwell's director of public health, said: "This is the calm before the storm. We are seeing cases rise quite sharply. We've had 26 cases in Sandwell over Saturday and Sunday. The weekend before there were only nine. When you look at the figures you can see we are on the cusp of something quite dangerous."

Dr McNally said she was concerned there were still too many people who had not had the vaccine, and noted "particular gaps" among "certain ethnic groups".

"If we thought we had seen the back of this pandemic we were wrong, because it is about to get back up off the floor and slap us on the back of the head."

Further 23 virus deaths in region's care homes

Meanwhile the latest 23 deaths confirmed in the region's care homes means 1,459 have died. Across the UK there has been another 12 deaths taking the total to 127,794. The most up-to-date statistics show 65,658,949 jabs have been given in the UK. Of those, 39,585,665 were first doses, and 26,073,284 second doses.
