Lime trees (G1) – a group of 4 lime trees overhanging a public footpath - crown lift to the same height as previous work (by about 2m), to reduce stress on the lower boughs and prevent over-loading and to maintain clearance for mowing garden maintenance. Also clear of dead wood for safety.
