The proposed like for like reglazing of the modern window unit is also acceptable instead of its complete replacement.

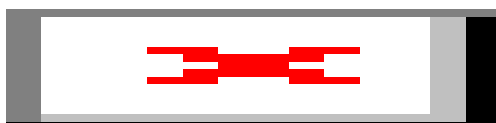
Validation team – Could this please be raised as a formal Discharge of Conditions case for condition 3 on application DC/21/02026?

Hi both

Many thanks for your previous help with this application.

The work on the sole plate has been progressing, and is nearing completion.

As noted previously, we are pursuing the replacement windows and doors in the modern extension as a separate matter.

We have now engaged Miles Rolfe (<https://www.milesrolfejoinery.co.uk/>) to do this part of the work – Miles has a good reputation locally including work on other listed buildings.

As requested, I am now submitting scaled drawings (provided by Miles Rolfe) to support this part of the LBC application. For reference, I also enclose the photos originally submitted as part of the LBC application.

These diagrams refer to the door unit only. We have decided not to replace the modern window unit, although we are intending to re-glaze using the same type of double-glazing.

Please can you let me know whether this satisfied the remaining conditions for the work, such that we can give the go-ahead for the work to start.
