e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T01 Beech – PRUNE: reduce N/NE facing fire damaged branches over Church Lane by 4m
T02 Horse Chestnut – PRUNE: reduce hollowing stem facing Church Lane by 5m in height
T03 Horse Chestnut – FELL: poor structural condition with decay and delamination in upper canopy over Church Lane and pole mounted utility cables in verge
T05 Sycamore – FELL: poor structural condition with lean to WEST over public right of way and reliant on bracing from tree in neighbouring property
T06 Sycamore – PRUNE: crown raise to 6m to remove branch striking SE facing eave of church roof
T07 Sycamore – PRUNE: crown raise to WEST (over east perimeter path) by 3.5m to reduce loading on west facing union in poor condition
T08 Sycamore – PRUNE: crown raise all round to 3m over south perimeter path
T09 Wild Cherry – PRUNE: crown thin by reducing 2no. emerging leaders back to main stem
T10 Wild Cherry – FELL: heavily leaning over gravestones and reliant on failing bracing from neighbouring tree
T11 Ash – FELL: poor specimen in reduced health with dieback in upper canopy over west perimeter path
T12 Sycamore – PRUNE: reduce NE facing branches up to 6m above ground level by 8m in length over perimeter path
T13 Sycamore – PRUNE: reduce NE facing branches up to 7m above ground level by 8m in length over path perimeter
