In response to your letter dated 13th July 2021.

- Happy with the description being "Remodelling existing property with 2 storey extension to west, Removal
 of front entrance porch; Two storey front gable roof extension; Single storey extensions to east and south,
 replacement front entrance gates and stone boundary wall and swimming pool to rear".
- 2. The existing Garage is approx. 120 cubic metres and its removal therefore requires consent. As this is clearly part of the application, I do not see what the issue is unless you want this to be included within the description above?
- 3. Additional dimensions on Block Plan (drawing 2008-24a at 1:200 scale) these are quite clear and do not need to be reproduced on all the floor plans.
 I have added the height of the front gable as requested to drawings 27a & 28a. The dimension shown on the North-West Elevation is to the new ridge (8600mm), not the existing roof. The 'raised part' you seem to be referring to is the gable coping. Please do not tell me that you need a dimension for that as well.
- 4. The Heras fence was shown on the previous application as there was no Tree Report required and this was the only way of showing this. The Tree protection this time is covered by the submitted tree report for your Officer to approve. This does not need to be duplicated on all the drawings as a 'planning matter'.
- 5. The swimming pool section has been added to drawing 2008-24a. The depth below ground level will be from 1.1m down to 2.4m.
