This amendment is to remove the 1.5m projecting section of the extension on the west side and form it so that the west side follows the line of the existing west wall. A small circular window is proposed on the new west facing wall. The rear door to the kitchen is to be moved.

These changes have been brought about by the need to simplify the construction, remove the need for a new retaining wall while the additional window will provide more natural light into the extended kitchen. There is now no need to alter the rear pedestrian access off the street. Repositioning the rear door to the kitchen will allow a longer run of worktop.
