Removal of Oak (tree 16) due to significant die back in the canopy. This may be due to excavation and compaction pressures around the base and beneath the canopy.
Replacement planting to greenspace area between no.s 9-10. Tree to be an English Oak 8-10cm girth. 2-2.5m tall.
