e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Pine (T1) Remove pine to ground level.
Silver Birch (T2) Remove silver birch to ground level.
Dying tree (T3) Remove dying tree.
Cherry (T4) Crown raise cherry to 4m.
Lime (T5) Crown raise lime to 4m.

Both Pine and Silver Birch are positioned in with a stand of trees and there is severe overcrowding. By removing the two trees it will allow surrounding trees to flourish and will also allow more light into the garden.

Dying tree is in decline and has no aesthetic benefit.

Both Cherry and Lime have low canopies and by raising to 4m will allow clearance underneath and will also allow more light into the garden.
