Damson (T1) Reduce & shape damson tree as the branches are severely overweight and the branches have begun to snap out. Reduce all limbs by 2-3m and shape accordingly.

Group of Damsons (G1) Raise group of Damsons to allow 2m above the wall, so that wall can be re-built.
