T16 - Beech - Outside 'BEECHWOOD' - Fused limbs, western side x 2 - Cankered limb overhanging the road.

Torn out limb @12m Major dead-wood suspended in low southern crown - Target prune remaining damaged branch back to stem - Remove all major dead-wood over road.

T79 - Sycamore - Opposite 'THE SHEILING' - 2 x major sized dead limbs on east & north sides @ 6-8m high - Remove major deadwood.

T80 - Sycamore - Opposite 'THE SHEILING' - 1 x major sized dead limb on north side @8m high - Remove major deadwood.

T81 - Sycamore - Opposite 'CELLANDINE' - Major sized deadwood and hangers suspended in the upper crown framework @ 6-13m high on north side - Remove major deadwood.

T84 - Beech - Opposite 'THE PAVILLION' - Major sized deadwood overhanging the road - Remove major deadwood.

T90 - Ash - Opposite 'SOUTH WINDS' - Sparse crown. Major sized deadwood throughout the crown framework and overhanging the road - Crown clean to remove all major sized deadwood.

T91 - Oak - Right of 'BROADOAKS' gates (verge) - Major sized deadwood throughout the crown framework and overhanging the road - Crown clean to remove all major sized deadwood.

T94 - Oak - Opposite 'HAUT BOIS' - Major sized deadwood overhanging the road - Remove major sized deadwood.

T95 - Oak - Stem wounding (west stem) historical vehicle strike @1.5m & 4-6m high. Poor reaction wood. Now exceeds risk tolerance level for safe retention - Reduce the western crown (i.e. the crown of the damaged stem) by 3.5m.

T96 - Oak - Low branching over road and interfering with overhead service cables - Crown lift over the road by 2m to allow for passage of vehicles and remove branches to clear around cables.

T97 - Beech - Adjacent to 'LA CHIMERE' - Major sized deadwood overhanging the entrance to VIOLET WAY - Remove major deadwood

T98 - Ash - Major sized deadwood overhanging the road at the "Give Way" point: "DANGER NARROW BRIDGE" sign - Remove major deadwood

T101 - Oak - Opposite barrier gate. (Estate access road) - 30% crown dieback. Old "pollard" with long false crown framework branches - Re-pollard to previous points.

T103 - Oak - On right-hand side verge of estate access road - Historical vehicle strike at stem base. Exposed heartwood. Sounding hammer testing suggests some decay hollowing, but good reaction wood is evident. Tree beginning to exceed risk tolerance level for safe retention - Crown reduce by 8-9m.

T104 - Pine - On right-hand side estate access road - Major sized deadwood (x 1) overhanging the road - Remove major deadwood.

T105 - Elm - Located opposite CALBDEC - Dead tree - Remove tree

T106 - Ash - Located opposite CALBDEC - Remove major deadwood

G5 - Elms x 3 - Located South the 'No Exit Ahead' sign - Trees are Dead - Remove

G7 - Elms x 7 - Located opposite CELANDINE & VIOLET WAY - Trees are Dead/Declining - Remove

G8 - Elms x 5 - Located left of estate access road - Trees are Dead/Declining - Remove
