e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Golden Lawson Cypress (T1) Fell. The tree has begun to crowd out an adjacent high quality specimen Katsura tree which is one of a pair forming part of the original planting scheme for the arboretum. There are other lawson cypress trees with in the arboretum so the variety of trees would not be diminished. This is part of an ongoing plan to fully restore the arboretum to reflect the original design and intension of the designer.

A hornbeam (3-4m) will be planted within the grounds as a suitable replacement.
