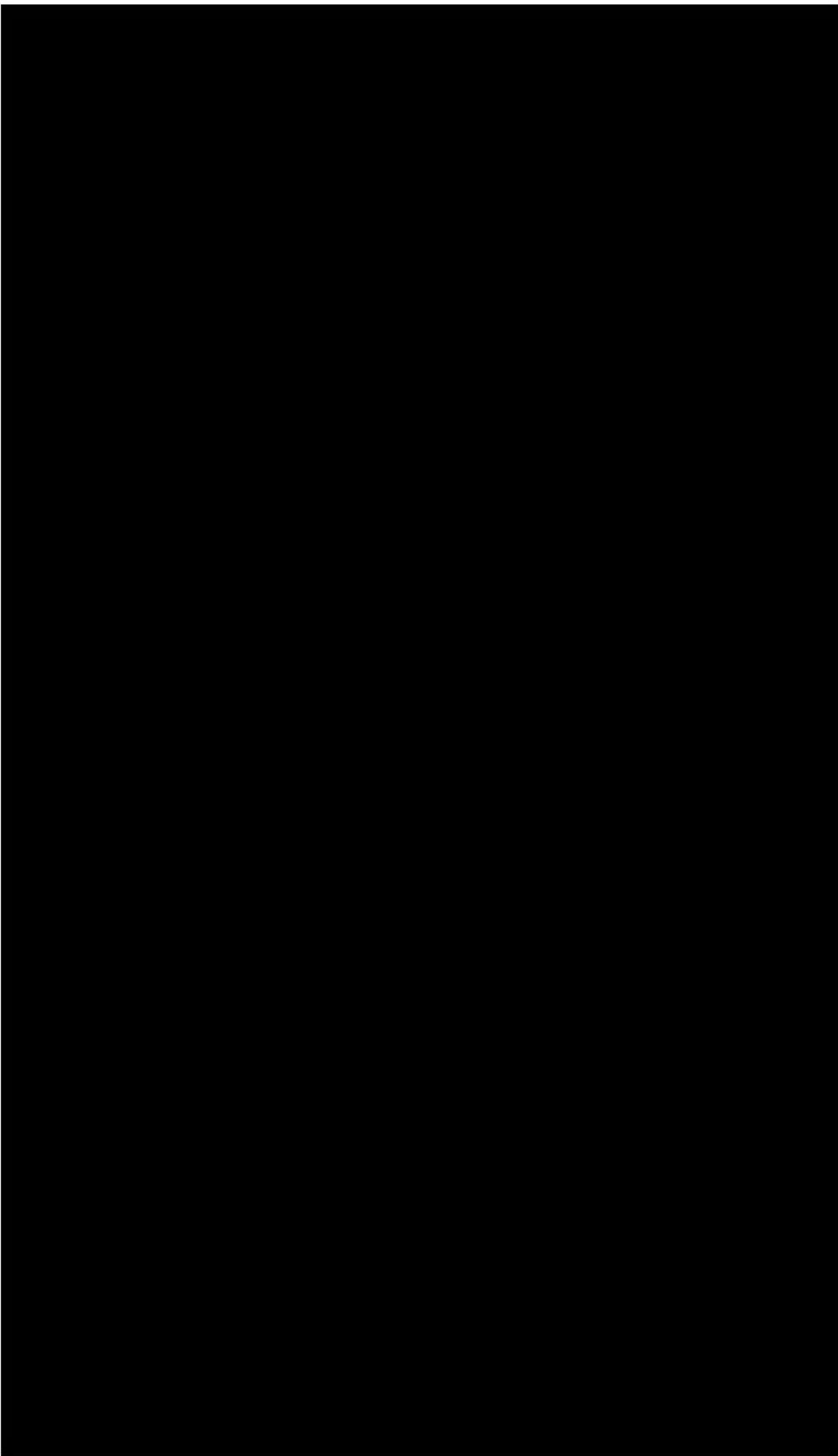
I have managed to get contracts for 11 Alexandra Road, from Tara & Co who are the letting agents. They've informed me there is no paper work/contracts etc for the earlier years as they only keep record for a duration of up to 6 years - all records/contract/information is destroyed after this time frame (I believe this may be due to the GDPR legislations). I have attached a copy of the email referring to this matter from David Quain for your reference.

As discussed with Andrew, I purchased 11 Alexandra Road, Leamington Spa, CV31 2DG in the early 1990's and this property has always been rented as a student property.

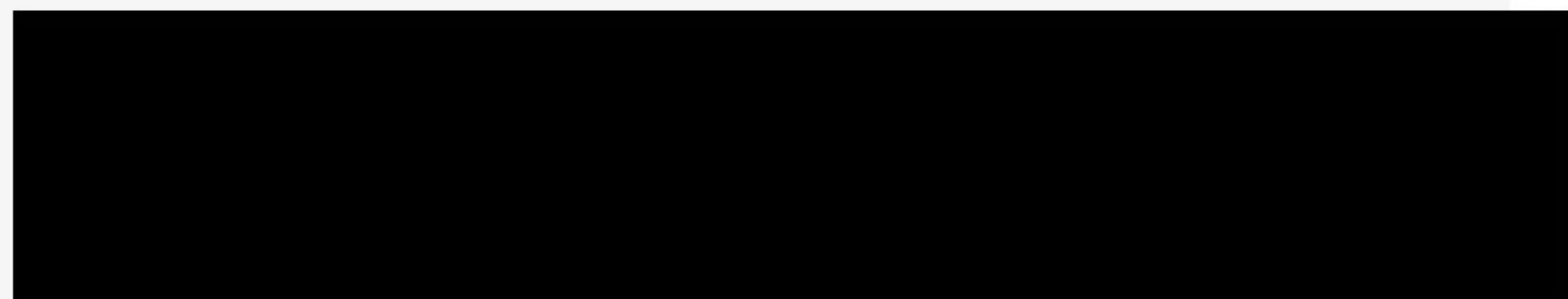
