Specific questions for development at 3, St Nicholas Street, Bodmin PL31 1AB

As per sketch, install 2 new staircases, block walls, remove modern plasterboard walls 3rd floor, create new timber frame wall 3rd floor.

Fit 2 Velux windows in rear roof top floor for each new house. The top floors become very warm in summer and this allows air flow. Max window height c75cm to fit between roof timbers

Replace rotten wood lintels with concrete / steel according to structural engineer recommendations and building control approval. These lintels will not be visible when fitted, as per the original lintels.

Where original structural wall areas have been removed previously, concrete block wall support to be provided according to structural engineer recommendations and building control approval. To be rendered over with lime to match existing finish.

Remove requirement for archeological survey on ground floor. Following repair of gutter leaks there is no damp and therefore no requirement for complex tanking. Following measurements of Radon gas, found to be at very low levels, Building Control do not now require Radon sumps or membranes.


Change modern front door on ground floor to an original Georgian 6 panel door with top two panels glazed. To be purchased secondhand.

Remove any requirement to re-fit a pub sign. This will be residential.

Request permission to fit photovoltaic or solar panels on the rear roof. (If we can get this agreement in principle in time, I will fit brackets when we do the roof)

I would propose we keep a large log burner on ground floor, possibly gas fired. Any suggestions on heating welcome! If solar on rear roof could be agreed, possibly look at underfloor heating?


