e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Cut Leaf Beech (T1) - reduction to a small number of branches in the lower crown which are creating excessive shade in the back garden. This would be a sympathetic reduction/thin to improve the amount of light to the bottom end of the back garden. By the very nature of the selective work proposed it is hard to give an overall percentage, but I would estimate this to be around 10-15%.
