Magnolia (T1) - Crown lift and reduction (1m). Low and encroaching over outdoor dining area.  
Apple (T2) - Fell. Very poor 80% dead.  
Plum (T3) - Reduce 1.5-2m.  
Cherry (T4) - Fell. Leaning heavily over greenhouse. Area to be developed.  
Robinia (T5) - Fell. Very Poor 90% dead. Large fungal brackets all over main stem.  
Hazel (T6) - Coppice.
