G1 a row of Sycamores, originally a hedge, have been allowed to become tall, request to reduce the upper crown height by 3.5 meters, cutting no greater than 100mm, and any stray branches leaning out to the West (property side) reducing back by 2m, cutting no greater than 75mm. this will encourage growth in the lower part of the stem and maintain as smaller trees in a hedge form.
