Tree 152 - A twin stem Ash with 40 to 50% canopy dieback likely to be caused by Chalara fraxinea (ash dieback). Action = Fell both stems. Replant with field maple/hazel/hawthorn or Guelder rose
Tree 153 - a single open grown Ash with over 50% crown dieback likely to be caused by Chalara fraxinea (ash dieback). Action = Fell both stems. Replant with field maple/hazel/hawthorn or Guelder rose
Tree 154 - Ash showing around 40% canopy loss likely to be caused by Chalara fraxinea (ash dieback). Action = Fell both stems. Replant with field maple/hawthorn/holly or Guelder rose
Tree 155 - Ash showing around 30 to 40% canopy loss likely to be caused by Chalara fraxinea (ash dieback), also as growing under competition from neighbouring tree the tree has poor form. Action = Fell both stems. Replant with field maple/hawthorn/holly or Guelder rose
