#### **EXECUTIVE SUMMARY**

The following presents a summary of the main findings of the report. It is emphasised that no reliance should be placed on any individual point until the whole of the report has been read as other sections of the report may put into context the information contained herein.

The site of Mayberry Garden Centre, and the currently vacant land to the west, at Old Shoreham Road, Portslade is to be redeveloped. The development proposals are understood to comprise the construction of a detached car showroom/service centre in the west, a large area of external car parking in the centre, and the extension and alteration of the existing garden centre in the east.

The eastern part of the site is currently occupied by a garden centre, with the remainder of the site comprising open land.

The site comprised open land at the time of the earliest inspected historical map, dated 1875. A gravel pit was excavated in the eastern part of the site before being backfilled and the area developed as a nursery. More recently the eastern area was redeveloped as a garage before it's current use as a garden centre.

The central and western parts of the site have remained undeveloped other than the construction and then demolition of electricity pylons in the central area. A large electricity substation is located to the south west and a petrol filling station is located to the east.

Reference to geological datasets indicates that the site is expected to be underlain by the Head or River Terrace Deposits overlying the White Chalk Sub Group.

The Head and River Terrace Deposits are classed as a Secondary Undifferentiated Strata and a Secondary B Aquifer, respectively. The White Chalk Sub Group is classed as a Principal Aquifer. The site does not lie within an Environment Agency Source Protection Zone with regard to the protection of the quality of groundwater that is abstracted for potable supply.

The preliminary contamination risk assessment has identified potential pollutant linkages relating to both proposed end users of the site and controlled waters.

An intrusive ground investigation is recommended in order to allow a quantitative risk assessment of the potential contamination sources that have been identified to be made. Investigation works should be targeted at the central and western parts of the site, specifically those proposed areas of decorative planting around the car parking lots.

The development proposals are understood to comprise the construction of a detached car showroom/service centre in the west, a large area of external car parking in the centre, and the extension and alteration of the existing garden centre in the east. A copy of the extent of the development site and the proposed layout are presented in Appendix A.

Ashdown Site Investigation Ltd was requested to provide a preliminary contamination risk assessment for the proposed development to support a planning application.

The specific objectives of the works were to:

- a) Establish the expected geology, hydrogeology and hydrology at the site;
- b) Ascertain the development history and current site use;
- c) Develop a preliminary conceptual model of the site identifying potential pollutant linkages relating to end users of the proposed development works, to controlled waters beneath and in the vicinity of the site, or to other off-site sensitive receptors, if identified.

The scope of the works covered by this report, and the terms and conditions under which they were undertaken, were set out within the offer letter Q9841, dated  $23^{rd}$  June 2020. The instruction to proceed was received on behalf of the client, Tates Bros.

The preliminary conceptual model has been based on the findings of a walkover survey and reference to historical Ordnance Survey maps and published geological and environmental information obtained from various sources.

Copies of the historical maps and geo-environmental data referred to in this report are presented within Appendix E.





### 2. WALKOVER SURVEY

The site comprises an irregular shaped plot of land located to the south of Old Shoreham Road, Portslade and is centred on the approximate Ordnance Survey national grid reference TQ 2521 0583. Photographs taken during the walkover survey are included in Appendix B.

The site is divided into three parts. The eastern part of the site is occupied by a garden centre. Access to the garden centre is off Old Shoreham Road, to the north, leading to an asphalt surfaced car park which occupies the south eastern part of the site. The garden centre occupies a number of units, with the main part being a large rectangular structure which appears to have a lower ground floor/partial basement on the southern elevation.

The central and western parts of the site currently comprise open land overgrown with tall grass, with areas of brambles in some places. The two areas are separated by a crushed stone surfaced access way with steel palisade fencing on each side. This provides access from Old Shoreham Road in the north to allotment gardens located to the south of the central part of the site. Two large electricity pylons are located immediately beyond the southern site boundary.

To the south of the western part of the site is a large electricity substation, with cables feeding into the pylons. A brick structure, housing electrical equipment bounds the western part of the site immediately to the south.

The remainder of the site is bounded by housing.

#### 3. ENVIRONMENTAL AND GEO-ENVIRONMENTAL DATA REVIEW

#### **3.1 Geological and Hydrogeological Information**

#### 3.1.1 Expected Geology and Aquifer Designation

The stratigraphic succession that may be expected to underlie the site is presented in the following table.

The superficial Head is a polymict deposit generally comprising clay and sandy clay with variable amounts of gravel and cobbles. The lithology of the Head reflects the nature of the parent solid strata; the gravel and cobble fraction comprising chalk and flint. The material is likely to have been disturbed by intense frost action in a periglacial environment. It is usually poorly sorted but may be stratified where it has been subject to solifluction and/or hillwash and soil creep. It may form infill to solution features within the chalk.

The River Terrace Deposits generally comprise well graded sandy fine to coarse gravel. Locally sand or gravel strata may predominate. Lenses of clay, silt and localised peat may be present.

The White Chalk Subgroup comprises a weak, white chalk locally with flint bands together with scattered nodular flints. It may be expected to have a deeply convoluted upper surface as a result of solution weathering. The presence of natural cavities in the chalk is very rare and solution features, if present, can be expected to be infilled with Quaternary deposits such as the Head or River Terrace Deposits.

The infill material may be significantly weaker than the surrounding chalk. Solution features can comprise pipes extending to several metres deep into the chalk or conical depressions and basin shaped structures.

It should be noted that the assessment provided within the data represents a generic assessment only. A site-specific assessment would require the undertaking of an intrusive ground investigation.

Historically, chalk deposits were often mined locally. Most commonly historical mines characteristically comprise a narrow shaft with a number of chambers radiating from the base. These structures are colloquially known as "deneholes", "chalk-wells" or "chalkangles". The depth of the features reflects the depth to the underlying chalk bedrock. The shaft width was commonly in the order of 2m to 3m, widening out into galleries at depth. The chalk was extracted for soil improvement and was usually applied directly to fields though sometimes the chalk was processed, typically by burning in kilns where the chalk was used to produce quicklime (calcium oxide). Once they had reached their limits the mines were commonly capped. Various capping techniques were used; examples include the use of upturned trees or brick arching. Records pertaining to the distribution of these localised mines are incomplete, usually being limited to features marked as shafts or the occurrence of circular depressions on historic Ordnance Survey maps. In the field they are most likely to be visible as shallow depressions, if at all.

Site inspection and inspection of historical maps extending back in time to 1875 does not reveal the presence of any significant features. The data searches do not indicate any significant risk of mines being present beneath the site and the risk is considered to be negligible to extremely low.

#### 3.1.3 Radon

#### 3.1.4 Groundwater Source Protection Zones

The site does not lie within an Environment Agency Source Protection Zone with regard to the protection of the quality of groundwater that is abstracted for potable supply.

#### 3.1.5 Groundwater and Surface Water Abstraction Licences

The closest groundwater abstraction licence is recorded to lie 807m to the west of the site. The abstraction is for process water.

No surface water abstraction licences are indicated within 1km of the Site.

#### 3.1.6 Surface Water Features

No significant surface water features are recorded within 250m of the site.

#### 3.1.7 Flooding

#### 3.1.7.1 Flooding by Rivers or Sea

The site lies within an Environment Agency Flood Zone 1. This is the lowest flood risk zone assigned by the Environment agency and is defined as land assessed as having a less than 1 in 1,000 annual probability of river or sea flooding (<0.1%).

#### 3.1.7.2 Groundwater Flooding

The site lies within an area where the British Geological Survey report the "Limited Potential for Groundwater Flooding to occur".



The GeoSmart Groundwater Flood Risk (GW5) Map (GeoSmart, 2020)<sup>1</sup> states that the risk of groundwater flooding at the majority of the site is negligible, however, 20% of the site, located primarily in the west and an isolated area in the east is at 'low' risk.

Based on the susceptibility of the site to groundwater flooding, a groundwater flood risk assessment is not considered necessary for the site.

#### 3.2 Data Review

#### 3.2.1 Agency & Hydrological Data

The data has been reviewed and any entries referring to locations on, or in close proximity to, the site that may pose a potential risk are discussed within the following table.

The application for respraying of vehicles was refused or cancelled and therefore this is not considered to represent a potential source of contamination.

#### 3.2.5 Sensitive Land Use

The data has been reviewed and no sensitive land uses that may be impacted by the proposed development have been identified within 500m of the site.

#### 4. HISTORICAL MAP REVIEW

Historical Ordnance Survey maps covering the area of the site have been reviewed and are summarised in the following table.

It is noted that each map presents information applicable at the time of the survey (or revision date) and is subject to surveying and cartographic errors and/or advances. Revisions to maps are made at irregular intervals and it is possible that significant developments may have taken place on or within the vicinity of the site that are not shown on the maps.

'In the Vicinity of the Site' generally refers to features of relevance within approximately 250m of the site boundary but may also include more distant features if considered to be pertinent to the assessment of the development history.

#### 5. PRELIMINARY CONTAMINATION RISK ASSESSMENT

#### 5.1 Introduction

The risk assessment considers the potential sources of contamination identified, the receptors that may be present in view of the development proposals and the contaminant pathways by which these may be linked. A complete pollutant linkage is only deemed to exist where all three are present and a site is considered suitable for use where no complete pollutant linkages are identified.

Where a complete pollutant linkage is deemed to be present, an assessment of the level of risk associated with the pollutant linkage has been carried out in line with current guidance<sup>2</sup>.

The level of risk is determined using the risk matrix presented in the following table. Classifications of probability, consequence and risk are presented in Appendix D.

#### 5.2 Basis of Assessment

The development is to comprise a new commercial/light industrial building in the north west, car parking across the central parts of the site and additional buildings to the north and south of the main garden centre in the eastern parts of the site. Some decorative planting borders are indicated around the outside of the car parking lots though, given the context of the development, end users would be considered very unlikely to come in regular or prolonged contact with soils in these areas.

A copy of the proposed development layout is presented in Appendix A. Should the proposed development plans be altered, a revised risk assessment may be required.

#### 5.3 **Potential Contamination Sources Identified**

The following potential sources of contamination have been identified by the preliminary contamination risk assessment:

- Historical landfill/backfilled pits to the east and within the eastern part of the site.
- Historical use of the eastern part of the site as a garage and laundry.
- Filling station to the east of the site.
- Electricity substation to the south west.

#### 5.4 Preliminary Conceptual Model

The preliminary conceptual model for the proposed development is presented in Appendix D.

#### 5.5 Recommendations

Complete pollutant linkages have been identified by the preliminary risk assessment. It is therefore recommended that an intrusive ground investigation should be undertaken to allow a quantitative assessment to be made of the risks posed to end users and controlled waters.

However, the eastern part of the site has only recently (circa 2010) been redeveloped as a garden centre from it's previous use as a garage. As no structural alternation, bar the provision of new frost canopies, are proposed in this area, and as the maximum level of risk in this part of the site is considered to be very low, investigation in this area is not considered to be warranted.

Investigation works should be targeted at the central and western parts of the site, specifically those proposed areas of decorative planting around the car parking lots.


