The above application has now been registered and the Council will aim to determine your application by the terminal date shown above, which is a statutory time period prescribed by Government. Please note that in order to protect customers and staff and control the spread of the Covid-19 virus, in line with the Prime Minister's statement, the planning department has moved towards more agile ways of working. This means that at this stage your application has gone through a simpler validation check of basic information/requirements, rather than the full check of all constraints, and therefore the planning officer allocated to your application may request further information from you during the course of the application. If on this further examination, we find that your application is incomplete, we may invalidate it at this stage. We have taken this approach to try get applications registered as quickly as possible and prevent any unnecessary delays in the processing of applications. Planning applications go through many consultation stages and processes, once validated they are passed to a Planning Officer, who will fully assess the application. Following these initial weeks, the Officer will continue to closely monitor your application, receiving consultation responses, answering questions raised from third parties etc. Once the application is at a point a decision can be made, the Officer will write his/her report and it will then be passed to the

Principal Development Officer for sign off. Following sign off, your decision will be sent to you. If your application is called to Planning Committee, your application will follow a slightly different path, details of which can be found on our website.

1. Description of Proposal

This will result in the application being determined by a Government-appointed Inspector instead of the Council. You may, however, agree to the Council taking longer than statutory period to determine your application. In all circumstances where this is the case, the Council will make a decision as soon as possible after the eight or thirteen week period.
