PLANNING (LISTED BUILDINGS & CONSERVATION AREAS) ACT 1990: Old College Tennis Club, Gallery Road SE21 7AB: Re-instatement of a tennis court and miscellaneous associated features and improvements including floodlighting

The Old College Lawn Tennis and Croquet Club have occupied this site since the 1930's. The proposal is to replace what was historically 'Court 8', which has since 1963 been used for playing croquet, with a new tennis court. The purpose of reinstating a tennis court on the historic site of 'Court 8' is to respond to an increased demand for tennis and a decrease in demand for croquet.

The advice offered at the pre-application virtual meeting with Southwark's Zaib Kahn and Andre Verster on 21 May 2021, and in preceding and subsequent correspondence and telephone conversations, has informed the developed design of the proposals and the preparation of the information that accompanies our application.
