Thank you for your application received on 7 May 2021. I am writing to inform you that your application is incomplete for the following reason(s):

- 1 In accordance with part A. 2. b) of Policy CM28.1 of Westminster's City Plan, please submit a signed proforma of Appendix A of the council's Code of Construction Practice, to confirm that you will comply with the relevant parts. Please note that this does not need to have been approved by the Environmental Inspectorate at this stage. A copy of Appendix A and further details of the code of construction practice can be found on our website: https://www.westminster.gov.uk/planning-building-and-environmental-regulations/code-construction-practice/appendices.
- 2 Please submit a structural methodology statement prepared and signed off by a Chartered Civil Engineer (MICE) or Structural Engineer (MI Struct.E) including supplementary geohydrology reports where this is not being provided by the same engineer that provides specific details of:
- 1) the ground condition both before and after the development including an assessment of the impacts on ground water flow, water levels and drainage and
  - 2) excavation, temporary works & construction techniques, including details of the

potential impact of subterranean development on existing and neighbouring structures.

3 Please provide a survey of trees on the site and trees located on land adjacent to the site (including street trees) that may be affected by the development. You should include a plan showing the position, branch spread and species of each tree. You should indicate which trees are to be removed, and which are to be retained and any works you propose to carry out on the trees being retained. You should provide evidence from an arboriculturist and/ or other appropriate expert to support any works proposed because of the condition of existing trees.
