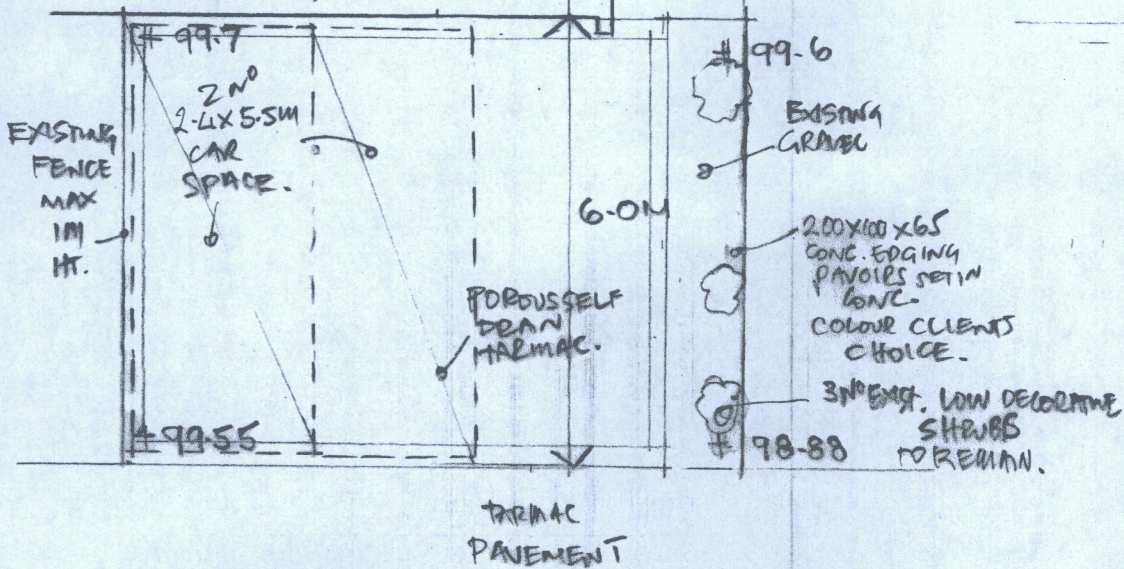

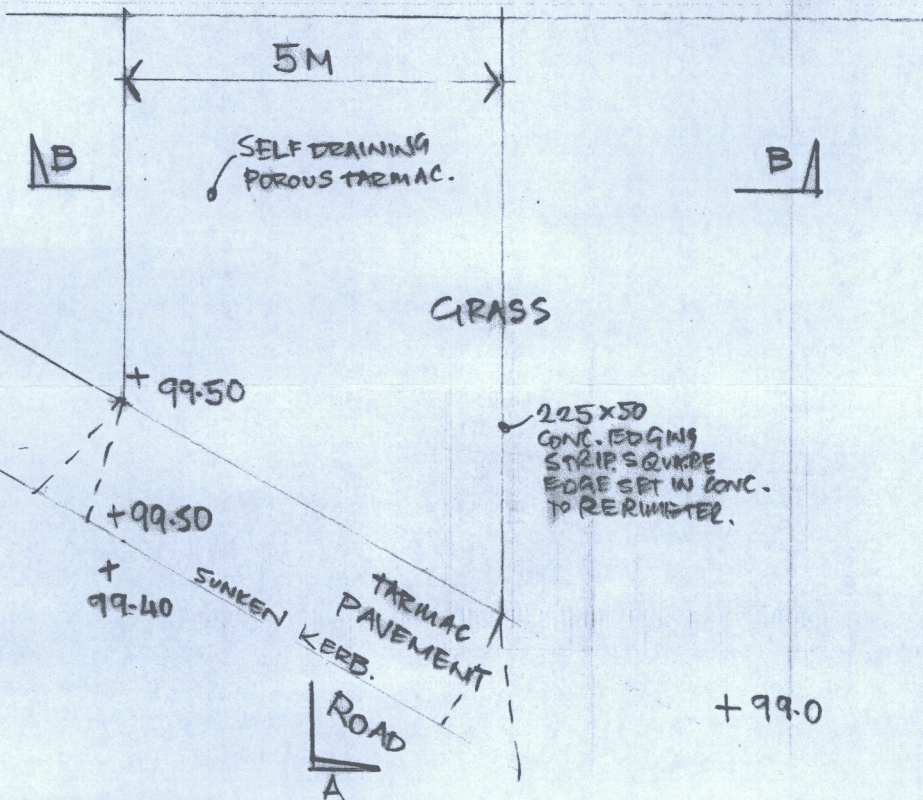

PAVEMENT ROAD



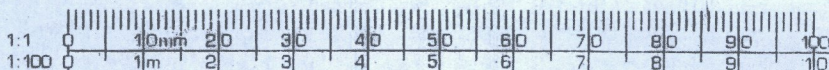
PROP. PLAN. 1:100.
