Front Garden Right Hand Side

T1 - Holly

Fell as close to ground level as possible.

Grind out stump to 200mm below ground level.

- The tree is located in the front garden left hand side.
- The tree is cracking the front wall and damaging the footpath and causing a hazard.
- Removing the holly tree will allow the adjacent yew tree to grow with a balanced crown

Front of House on Footpath

T2 - Maple

Reduce length of all branches by up to 3 metres in crown height and 2 metres in lateral growth. Lift to 2.5 metres from ground level and remove lateral branch rubbing against larger limb.

- The tree is located outside the front garden at the front of the house.
- The works will encourage a well balanced crown for future years.
- The proposed works would not reduce the amenity value of the tree and allow sustainable tree management in the long term.
