e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 Holly, over-sized, untidy and of poor form; fell to permit space/light for border planting of flowering shrubs.

T2 Pittosporum, over-sized for location, unmanaged; fell to permit space/light for border planting of flowering shrubs.

T3 ?Sorbus, fell in order to showcase neighbouring Cordyline of good health and form; very fitting in this location (Falmouth, close proximity to Gyllyngvase Beach). Prune back understory.

H1 Hedging of mixed plantings; Reduce height to approximately 3 metres with exception of Cordylines (preserve and showcase).
