T1- Mature Sycamore tree - Climbed to dismantle canopy and associated co-dominant stem closest to property  
Heavy tapering branch on remaining co-dominant stem pruned back to alleviate stress at base following exposure from stem removal highlighted above - see Fig 2

The reason for the above works is because the applicant feels the canopy in its current state is blocking out too much light into the property and shades out too much light for planting proposals beneath.

T2 -1 x Mature twin stemmed Conifer tree - Both stems climbed and reduced by 40% in height (approx.).  
Centre stems reduced slightly lower than green foliage to promote natural looking top.

The reason for the above works is because the applicant feels the canopy in its current state is blocking out too much light into the property
