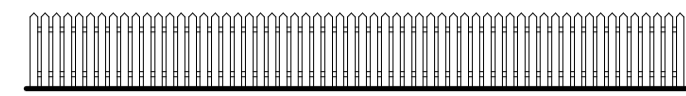
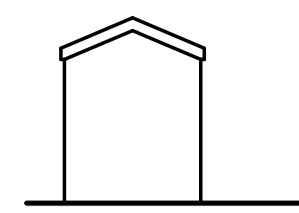


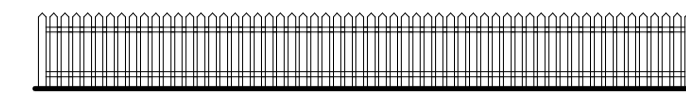

Rear Elevation (1:100)



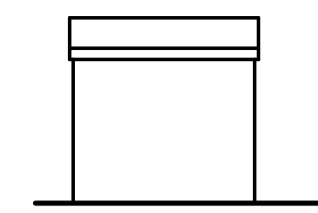

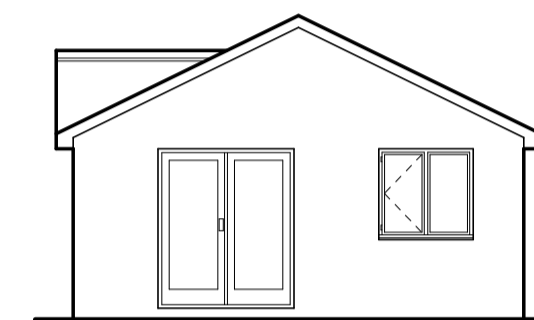

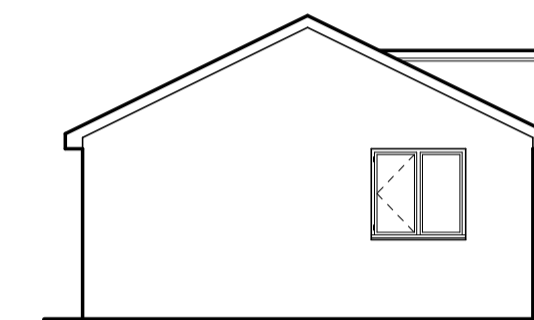

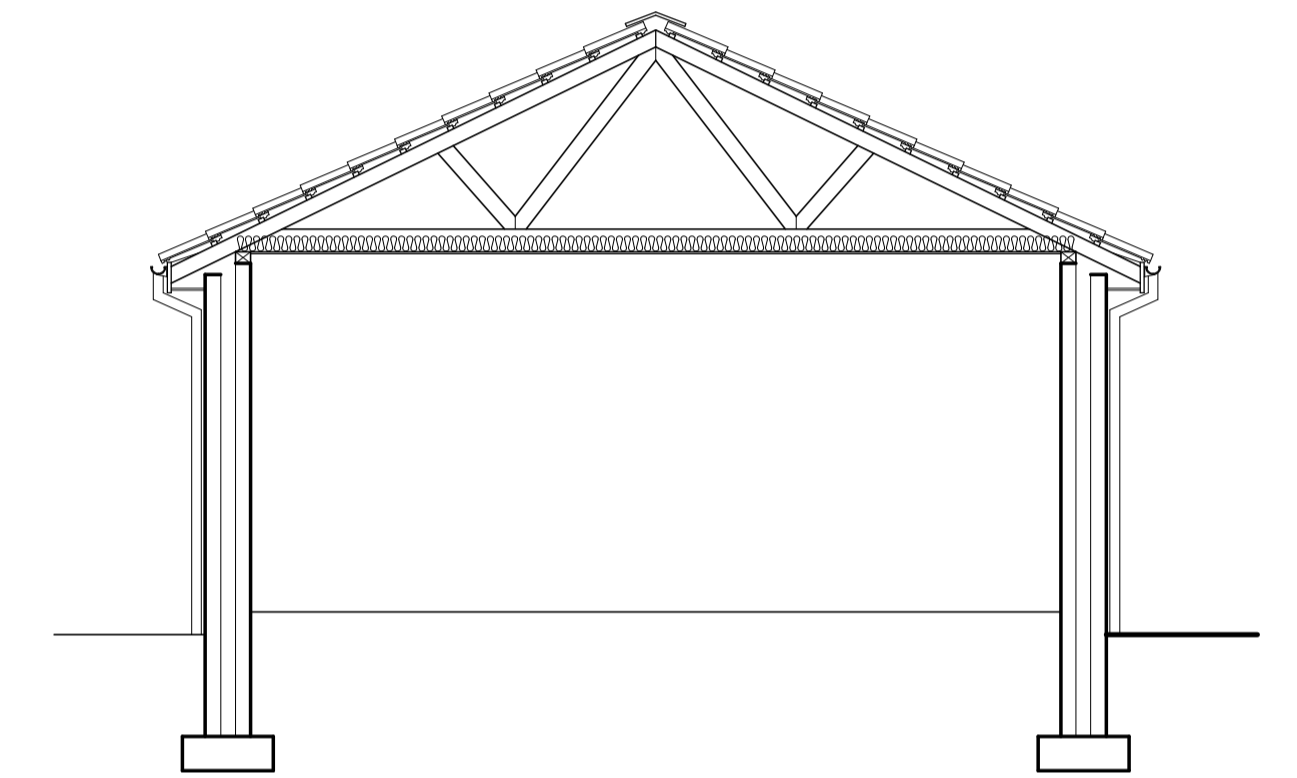

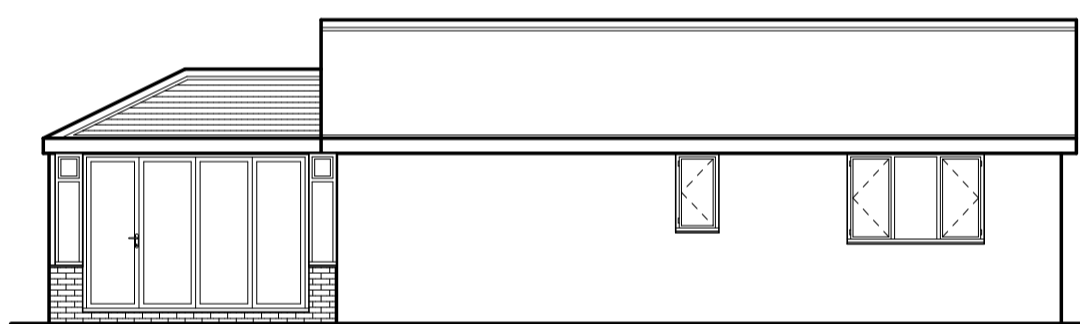

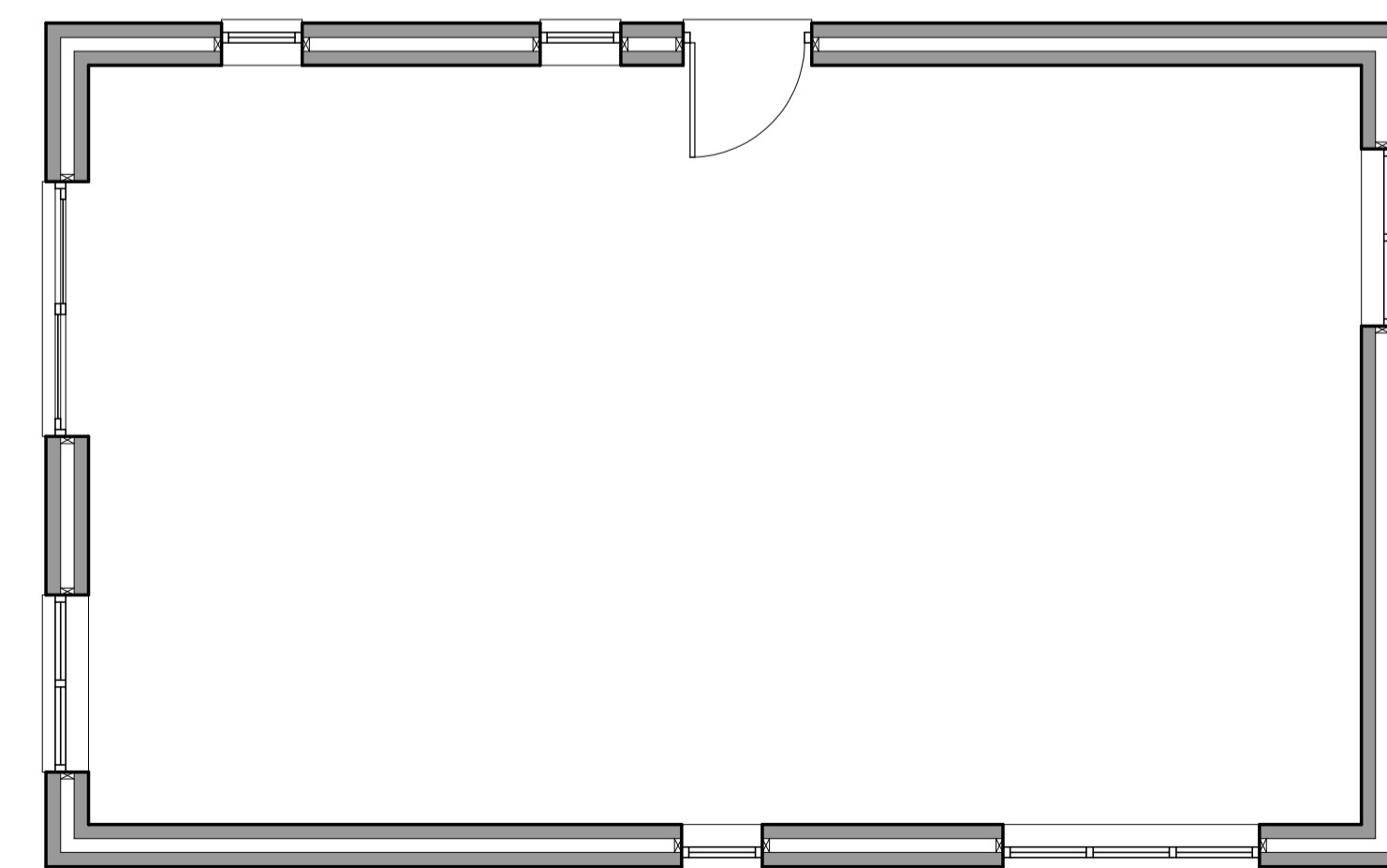

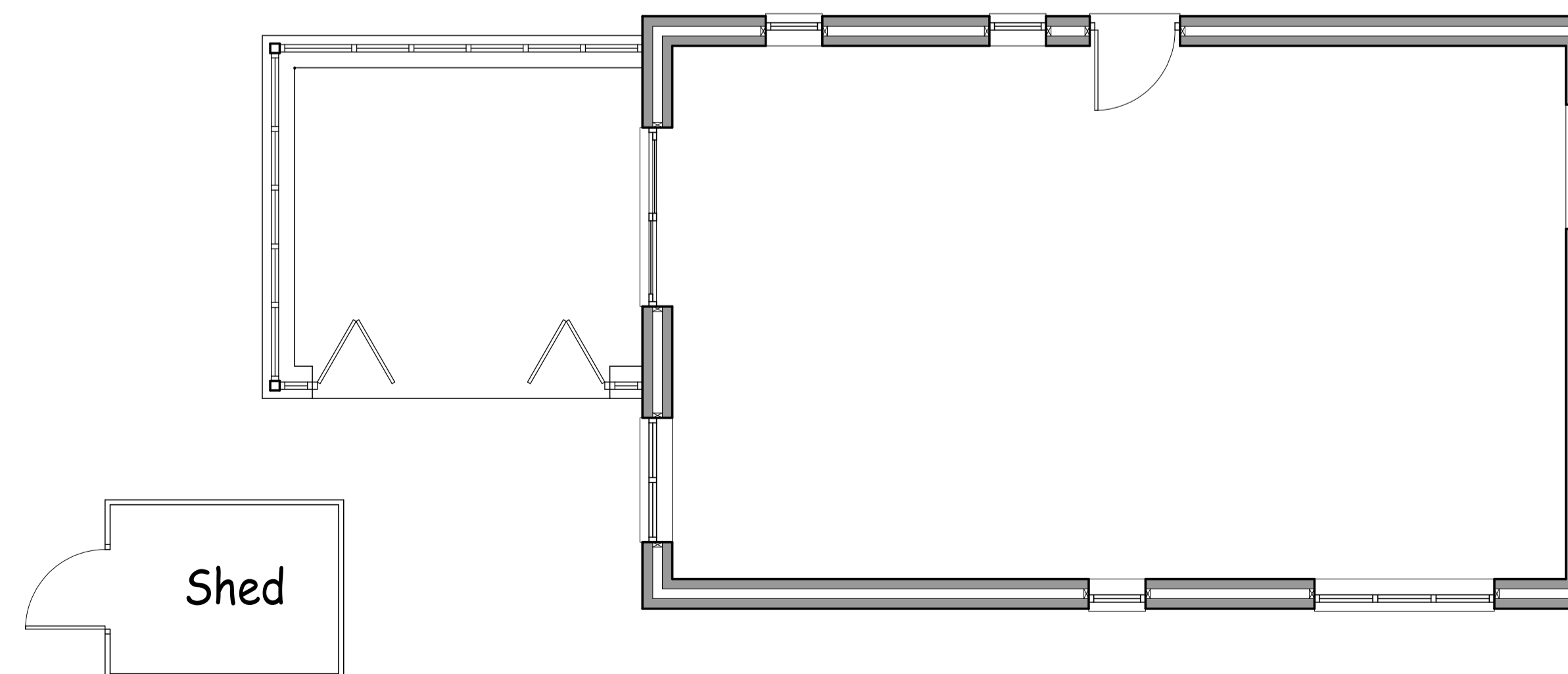
