e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - conifer - fell because of proximity to our house and our neighbour's house. It is also damaging the guttering, fasciae and soffits. It causes excessive shading to the garden and is blocking the light into both houses. It has grown up into the overhead cables and has blocked out the signal to our Sky.
T2 - ash - fell due to the close proximity to my house and my neighbour's house. It is blocking the light into their house and is touching the roof line of both houses. It is causing excessive shading in the garden so nothing else is growing underneath it. We have been advised that it will eventually damage the foundations of the properties as it is only about 10/12 years old.
