Low volume water car washing techniques will be employed to minimise the volume of water used per car. A proprietary K'Archer or similar approved system comprising an extraction sump pump and filtration system will be installed in line with the existing surface water drainage system. This will feed back into an above ground 1000litre water storage tank . The estimated throughput of cars is 120 cars per week. The solid waste removed by the filtration system will be stored on site and removed at regular intervals by a registered waste carrier.
