Tree details:

- Arbutus unedo
- Main trunk girth approx. 75cm before it branches out
- Canopy width 4m wide overall
- Tree height approx. 4.5m

We would like to remove the Arbutus unedo tree because this is overgrown for its location. The tree is too close to the house, where the client is planning to build a rear extension. The trunk is touching the boundary fence and is slowly pushing the fence panel. There is another very large tree (Pittosporum tenuifolium) adjacent to the Arbutus unedo and the canopies are crouching together and losing their shape. The Pittosporum tree will have more room to grow once the Arbutus is removed. The client's rear garden has over 8 mature trees and the loss of the Arbutus unedo will not affect the site's amenity.
